1162/19: Approval of the Minutes of the meeting held on 26/03/19: Cllrs Woolley and Keen

1163/19: Matters Arising: Police have not used the Village Hall yet, they do have the code, there is WIFI, tea & biscuits

1164/19: County Councillor's Report: Cllr Davies reported that he was pleased to have retained his seat at Williton with a large majority. He also reported that because of the

elections not a lot was happening at County, he advised the Parish Council to continue using his current email as the new one was not up and running. He also reported Somerset Building Trust had erected the metal prop on the end of the Chantry Building in Sea Lane. He asked Mr Lewis if he had received a reply from English Heritage, he replied that he hadn't.

The Chairman thanked him for coming.

1165/19: Report from District Councillor: None

1166/19: Specific Roles that Cllrs have now and are there any additional ones that could be undertaken that would be beneficial to the Community: Cllr Collins asked "Speed Watch" and why we did not have one in Kilve, The Clerk reported that there use to be one however the Police took the "Gun" to be recalibrated, shortly after the "Speed Watch" scheme was stopped.

Cllr Collins suggested that the Parish Council investigated recently advertised "Auto Speedwatch" discussion followed and it was agreed that it was worth pursuing, Cllr Collins stated he would look into it.

1167/19: Chairman's Update: Cllr Keen reported that he had very little to update on, projects were progressing well and thanked those involved.

1168/19: Cllr Woolley: Kilve Court Land/Neighbourhood Watch: Cllr Woolley reported that she and AK had a meeting with Daniel Moncrieff (KC) and Charlie Field (CC) with regard to leasing a plot of land from Kilve Court for a Recreational Facility, no decision or details yet. She also reported that 53 Households have joined Neighbourhood Watch, approx. a 1/3 of the Village, Cllrs Woolley and Grigg are determined that every Household in Kilve will become members, more forms will be circulated via Kilve News.

1169/19: Cllr Walton: Beach Project/Communication: He Reported that the tables will be fitted on Saturday, the

Cricket Club had kindly invited the fitters for Cricket Tea, The tables will require securing in the ground with special fixings approx. half a metre long at a cost of approx. £150 for 5. The tables nearer to the Beach will be positioned further back. There have been several comments that the PC do not publicise what they do for the Village. Should we have our own website as Holford do? Cllr Keen stated that Adam Gorman does a good job and will put on whatever we send him. The Chairman thanked him for all the work on The Beach project.

1170/19: Cllr Whitehead: Chantry: Mr Lewis from Hilltop, reported to the PC that he had been in contact with Historic England about the state of the Chantry site and what their intentions are. In their reply they stated that intend to tidy the site, replace the unsightly fence with a better one, remove the metal structure when safe to do so, still a lot more pointing to finish. Cllr Whitehead asked if visitors will be able to walk round it when finished. The Chairman suggested that Mr Lewis liaise with Cllr Whitehead so that the PC is kept up to date. He thanked him for coming.

1171/19: Cllr Collins: Footpaths/Bridleways: Cllr Collins reported that he had been in contact with Greg Martin County Rights of Way regarding the state of the Bridleway from Hilltop Lane to the A39, some of the other footpaths require attention. Discussion followed.

1172/19: Clerks Report: Insurance renewal, Finances, dates of meetings: She reported that the Public Liability Insurance held with Zurich was due for renewal £330.30 all agreed, the precept £5,500 had been paid giving a total balance of £17,500, the money for the benches, a contribution to the Beach Information Trail plus the proposed Recreational Facility, 6 cheques were signed. 1173/19: Items raised by Councillors: Cllr Collins asked about the Tree Stumps by the Church, if they were going to be removed, Cllr Keen understood that they were going to leave them to rot down as it was expensive to have them removed. Cllr Collins stated that he would get a quote from a company that he has used. Cllr Woolley reported that some parishioners who use mobility scooters would like the permissive footpath strimmed closer to the edge so they can use the path. The Clerk said she would speak Kilve Court. Cllr Collins stated that Mr Rutt reported that The spreading lorries are damaging kerbs. The Clerk reported that she had received an email regarding VE Day memorials 2020, it was agreed to put on agenda for next meeting.
