1137/19: Matters Arising: Still issues with carpark nothing else can be done, recycling issue in Millands people involved do not want help, will monitor the situation, Cllr Grigg to contact WS Ambulance re Defibrillator, agreed to keep precept the same.

1138/19: County Councillor's Report: CCllr Davies reported because of Christmas and the New Year it had been a quiet period, mostly about Highways Works:

1st- 13th February 2019: Temporary Closure A39

Minehead to Williton from 150m NE from junction with Sandhill Lane, NE for a distance of 10 metres.

Works are expected to last 1 Evening (18.38-23.30hrs) Order effective on 13th February 2019, remain in force for 18 months.

2nd – 18th February 2019 Temporary Closure, North Street, Williton, expected to last for 3 days to enable BT Open Reach to gain safe access to carriage way box to Provider customer service to be carried out. A-Plant Lux Traffic Control will be in operation.

3rd to 4th to 29th March 2019, Doniford Road, Williton, Road space has been booked to start on St Peters School Crossing, start date will depend when main contractors

can access site. More information nearer the time. 4th to 18th March and finishing on 31st March 2019, A358 Drainage & Resurfacing at Black Arch Bridge, Sampford Brett. This scheme has been on the back burner waiting for funding, this location will be CLOSED 24/7 to enable the work to be carried out over a two week period. This will create a major problem for all travellers. I have written to Somerset Highways as not received plans of proposed diversions. Has any thought been given to the "BLUE LIGHT SERVICES" as this road is the ONLY fast and direct route to Taunton. Cllr Davis reported that he had heard today that repair works to the A39 EQH for resurfacing would be done 6th-8th March 2019. He also reported that Bus Passes are for life and would be Reviewed every 5 yrs for usage. If the Bus Pass holder Fails to inform SCC of change of Address they will be Charged a £10 renewal fee. If the Bus pass is used in London SCC are unable to track because of the "Oyster System" although it can be tracked in other areas. Discussion followed. The Chairman thanked him for attending.

1140/19: The Somerset Wood: This is a new partnership with TDBC, Cheddon Fitzpaine and West Monkton PCs to create the Somerset Wood, to commemorate the County's fallen in World War One. It will cover 9.5 hectares and comprise of 11,281 trees, this number will match those listed in The Somerset Book of Honour which is kept in the South Transept of Wells Cathedral. After discussion it proposed by Cllr Woolley and seconded by Cllr Grigg to donate £100 for 4 Trees.
